Preamble

This Contract is based on a master agreement provided by FIBA - Fédération Internationale de Basketball pursuant to the FIBA Internal Regulation governing Players & Agents.

1. Engagement

The Club hereby employs ______to act as **a player** and he/she is hereby agreeing to play for the Club.

The Club shall advise, assist and represent the Player in connection with the engagement of the Player as a skilled basketball player by other clubs worldwide [with an exception of the player's participation in the National Team].

2. FIBA Internal Regulations Governing Players.

The Parties agree that their relationship under this contract, in particular, their respective rights and duties shall be governed by the Tanzania Basketball Federation (TBF) and FIBA Internal Regulations governing Players & Agents (hereinafter the "FIBA Agent Regulation") as amended from time to time.

3. Compensation

For any contract procured by or on behalf of another Club and signed by the Player before it's the deadline, the Player agrees to pay _____% of the Player's transfer fee/Contract value to the Club as Compensation. The Player is released from this obligation in the event that the player contract has reached its deadline and wishes to join another club. The Club shall not be entitled to reimbursement of any expenses unless otherwise agreed in writing. and

For any contract procured and signed by or on behalf of the Club, the Club agrees to pay the base net amount of ______ to the Player for the duration of _____ month(s).

4. Term

This Agreement shall begin on the day of signature hereof by both parties and shall expire on [not to exceed two years] unless renewed by written agreement between the parties].

6. Eligibility

A player shall be eligible for a contract; if he/she is or will be at least nineteen (19) years of age during the calendar year in which the contract is signed.

8. Confidentiality

The parties agree to keep confidential the contents of this Agreement and any matters related thereto.

9. Arbitration

Any dispute arising from or related to the present contract shall be submitted to the Tanzania Basketball Federation (TBF) for arbitration in Dar Es Salaam, Tanzania. If it concerns international transfers shall be submitted to Basketball Arbitral Tribunal (BAT) in Geneva, Switzerland and shall, be resolved in accordance with the BAT Arbitration Rules by a single arbitrator appointed by the BAT President. The seat of the arbitration shall be Geneva, Switzerland or anywhere agreed by both parties. The language of arbitratiothe n shall be English. The arbitrator shall decide the dispute ex aequo et bono.
